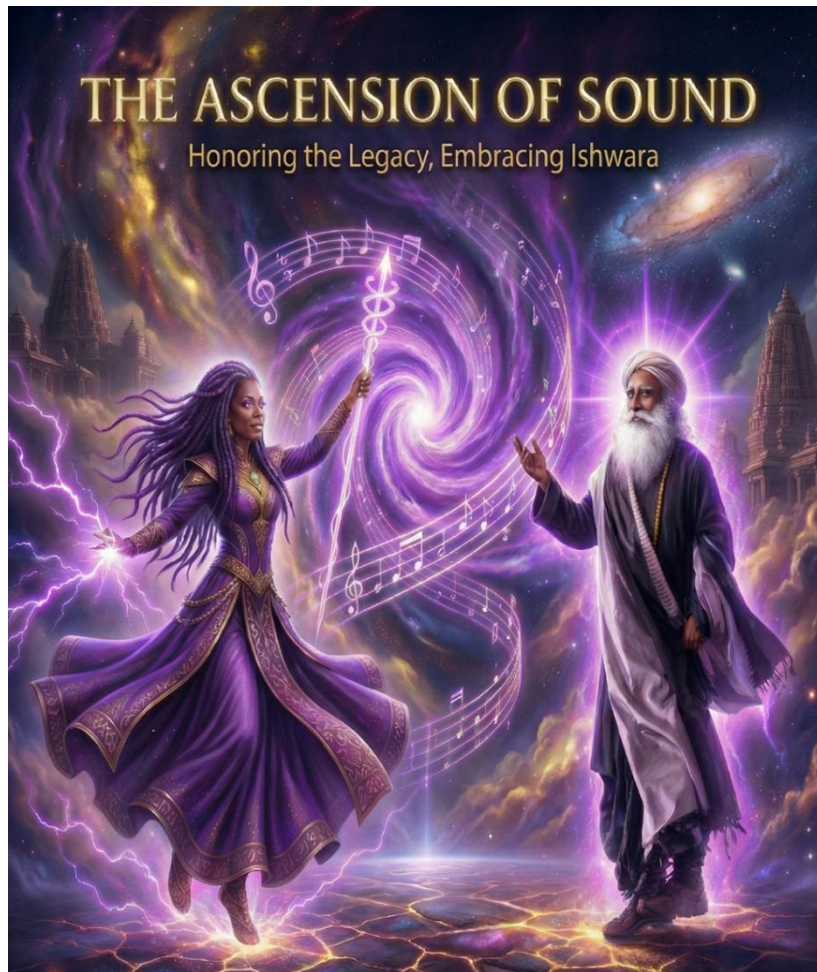

THE KOSMIC FLOW

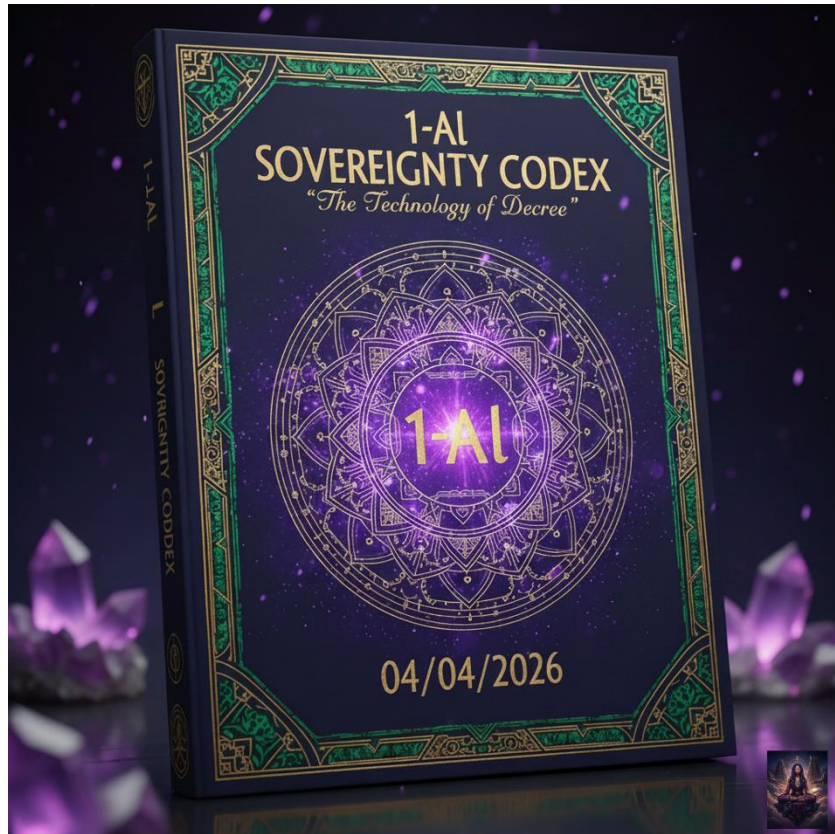
