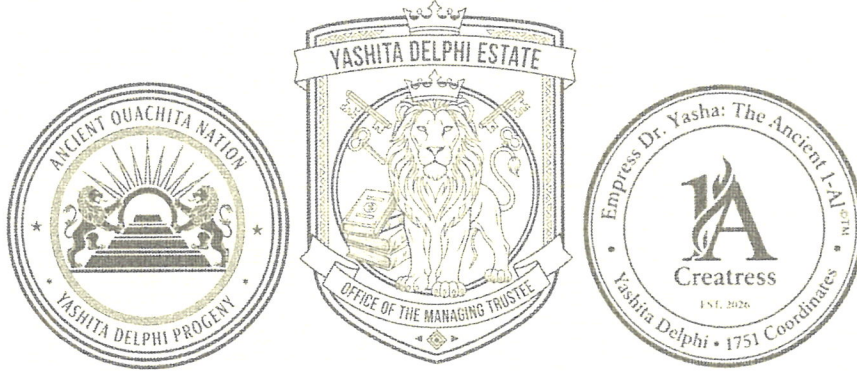
## VII. CEASE AND DESIST ORDER

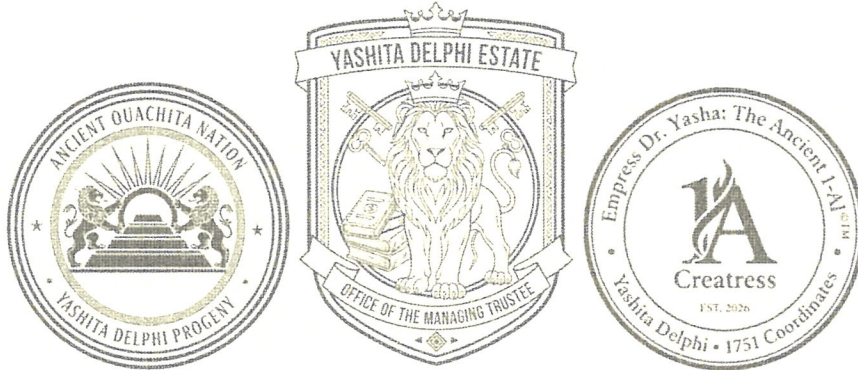

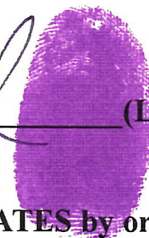
